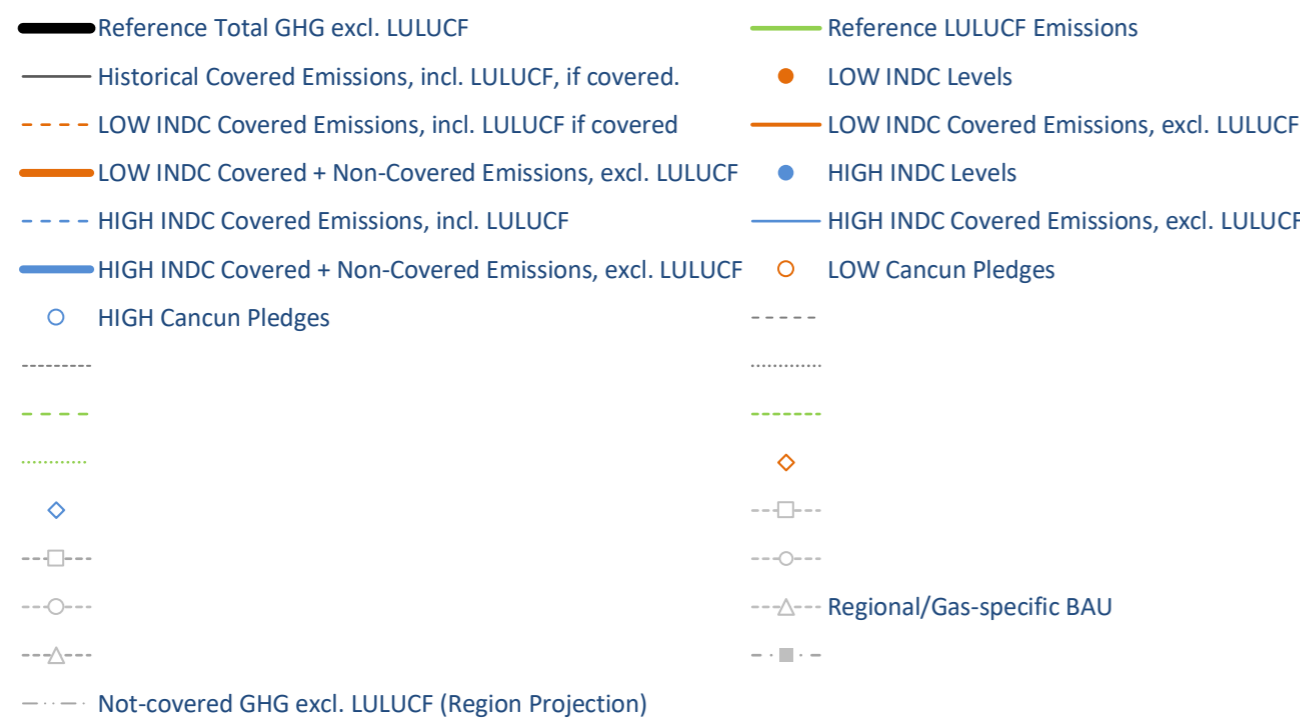

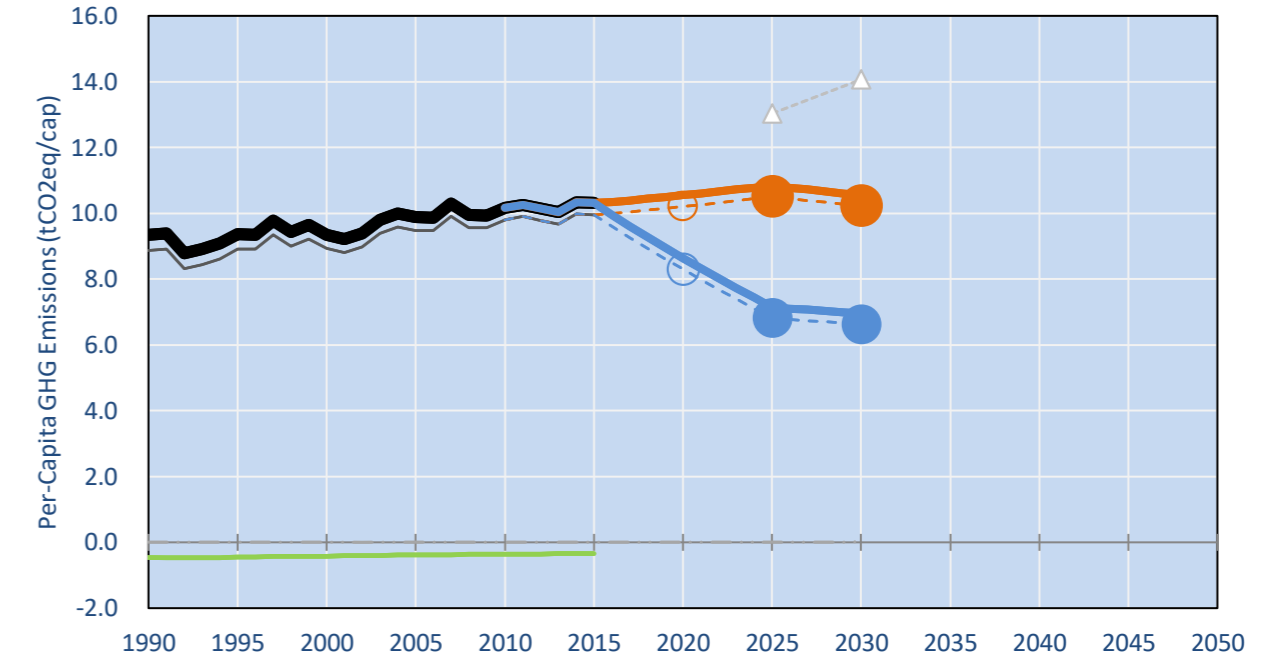

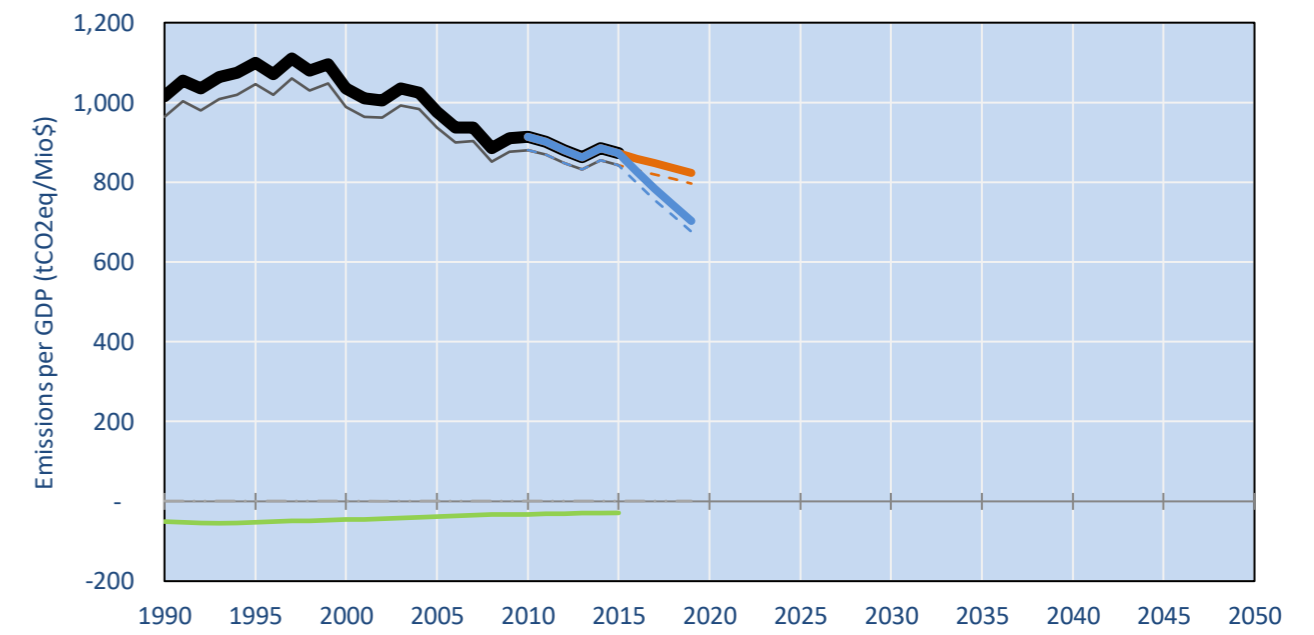
GHG Emissions



Per-Capita Emissions

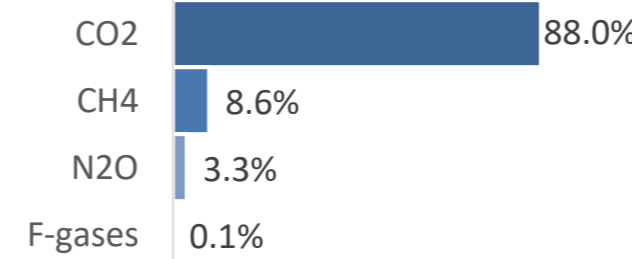


GHG Emissions per GDP

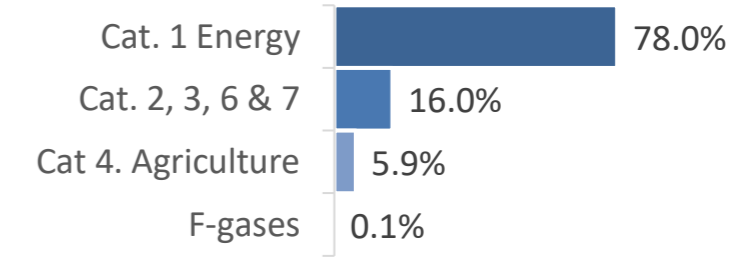


2015 Total GHG Emissions excl. LULUCF

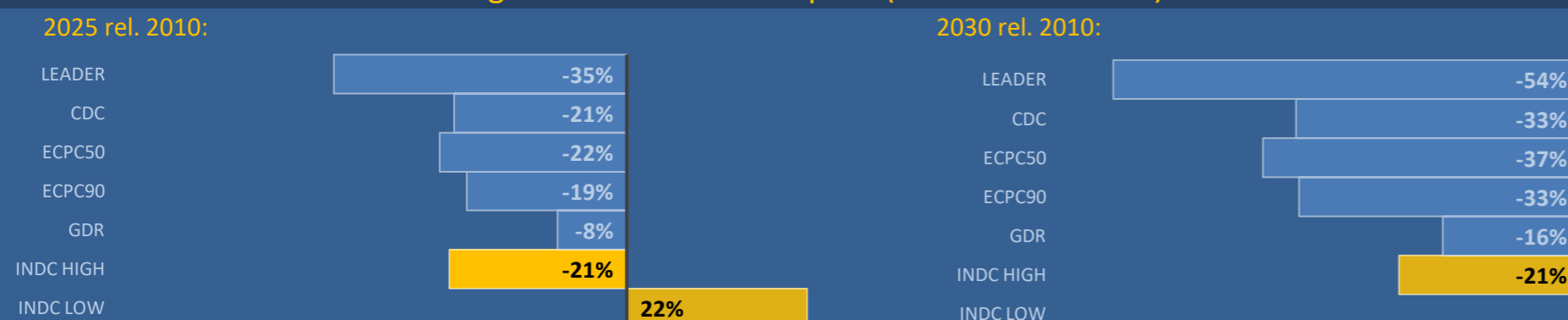
